## Workshop

A busy was had by all those who attended the workshop today. Currently most members are all working on or involved with several projects, all were aided and progressed today with activities on both Appliances 32 and 24 being the most active. Stuart and Larry are making great progress on 24 next week we will attempt to present some updated pictures to show the improvement.

No 32 while not changing in looks has Brakes, a hand brake and clutch along with an engine capable of driving the vehicle around the premise. Today the driver door window has been fitted and door handles and locks made operational again. Work on the rear of the cab continues along with the lockers and rear area. It will not be long before we will be looking to see if funds can be found to return her to the original colour.

Appliance 26 was presented for the WOF which sadly was returned to us rejected, due to the brakes not applying evenly on all four wheels. A common problem when vehicles are not moved for some time.

Other items attended today, battery post replaced, sorting of metals for scrap and attention to the engine of the Cadbury wagon. The engine head gasket was replaced following a serious overheating following the reassembly it has been found that water has entered the cylinders again. As a result the head has been removed again and further investigation into the condition of the head is now proposed.
